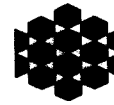

**TITANIC SIGNATURE PROJECT - CLARIFICATION OF RESPONSE TO DETI
ORAL QUESTION (AQO 823/10)**

I am writing to you with regard to the response I gave to the supplementaries to Jimmy Spratt MLA's question on the Titanic Signature Project during Oral Questions on 23 February 2010.

It has been brought to my attention that the answers I gave to the supplementaries, asked by Jennifer McCann MLA and yourself, could have been clearer on several points, as set out below.

Sustainability Clauses

Titanic Foundation Limited (TFL), in consequence of the significant public sector funding for the Titanic Signature Building and as required by the Central Procurement Directorate, have placed a contractual obligation on Harcourt Construction (NI) Limited (HCL) to deliver 'sustainability clauses' (clauses developed and agreed for use within public sector contracts under the umbrella of CIFNI, the Construction Industry Forum for Northern Ireland), which include, among other things, employment opportunities for the long-term unemployed and the creation of apprenticeships. The delivery on these 'sustainability clauses' is reported on monthly to TFL by HCL under the contract management arrangements.

Memorandum of Understanding

The Memorandum of Understanding (MOU) between Belfast City Council (BCC) and Titanic Quarter Limited (TQL) relates primarily to the wider Titanic Quarter regeneration development and places no obligations on either TFL or HCL, although it is an annexure to the Titanic Signature Project Master Funding Agreement. In signing the MOU both BCC and TQL (the co-signatories) committed to work in partnership with public, private, voluntary and community sector organisations to create the necessary conditions to optimise the city and community benefits of the Titanic Quarter development, to demonstrate good corporate citizenship and provide a recognised route for Titanic Quarter's engagement with the city and community.

In order to achieve the objectives set out in the MOU a number of priority areas have been identified and assigned to Thematic Working Groups, who are responsible for taking forward the development, implementation and monitoring of the overall Implementation Plan and its sub-component action plans. These priority areas are:

- Employment, Education and Skills
- Accessibility and Transport
- Community Outreach
- Housing
- Tourism Development and Promotion, and,
- Quality Open Space and Public Art.

Award of contract

Harcourt Construction (NI) Limited was awarded the design and build contract for the Titanic Signature Building by Titanic Foundation Limited on the basis of Titanic Quarter Limited exercising their exclusive rights over the site. The award of the contract was in accordance with Regulation 14(1)(a)(iii) of the Public Contracts Regulations 2006.

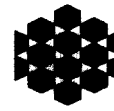


